Regulation

Mareblu Camping Village, wishing you a pleasant stay, reminds you of a few rules to follow:

- 1) **Check-in.** Upon arrival, guests are required to provide their identification documents for registration. Minor guests will be admitted only if supervised by parents during the whole stay. From June to September, the camping village requires guests to wear identification wristbands, which will be provided at check-in.
- 2) **Placement.** The occupation of the pitch is subject to the approval of the management. The positioning of caravans, campers, or tents must not block the normal traffic flow.
- 3) **Price list and payments.** ¹Daily accommodation costs are displayed at the reception and are valid until 11:00 AM on the following day. The pitch must be left free between 08:00 AM and 11:00 AM to avoid being charged for the entire day.
² Payments can be made by cash or credit/debit cards. Guests are advised to pay the day before departure to avoid last-minute queues (cashier hours: 08:00 AM - 7:00 PM). Nearby the reception is available an ATM (it is not owned by the property).
- 4) **Behavioral and Hygiene Rules.** ¹It is the duty of every guest to respect nature and everything the facility offers, and to report any disruptions or vandalism. It is strictly forbidden to dig trenches or holes, hammer nails, tie ropes to trees, pour hot or salty waste liquids on the ground, or damage flowers, plants, services, or equipment in any way.
²Guests are required to maintain hygiene and cleanliness at the campsite, and to use the dishwashing and laundry areas only for these purposes. Children must be accompanied to the toilets, and parents are directly responsible for any dangerous, disruptive, or harmful behavior of their children.
³ Any infectious diseases must be reported immediately to the management or the on-duty doctor.
- 5) **Fires.** LIGHTING FIRES IS STRICTLY PROHIBITED. The use of charcoal barbecues is allowed only at the designated barbecue areas, or guests can use their own near those areas. In case of adverse weather conditions (such as strong winds), the management reserves the right to prohibit their use. Only gas grills are allowed on the pitches.
- 6) **Access to Pitches/Mobile Homes and Parking.** ¹ Vehicle access inside the campsite is allowed only upon arrival and departure, to facilitate the setting up and dismantling of equipment. For any other unloading, special carts are available, which must be returned immediately to their designated place after use.
²The campsite provides each unit with an uncovered parking spot in designated parking areas, but declines any responsibility for theft or damage caused by third parties. Access to parking is controlled by magnetic cards, given at check-in with a € 10,00 deposit. Vehicles must display the control PASS on the windshield at all times. Vehicles not registered at reception and found in the parking lot without a PASS and magnetic card will be charged the rate starting from the first day the facility opens. Guests with motorcycles or similar vehicles may access the pitch/mobile home within the following hours: 08:00 AM - 2:00 PM / 4:00 PM - 9:00 PM. These vehicles must be parked within the boundaries of the respective pitch/mobile home.

- 7) **Waste Separation.** For waste collection, the campsite provides bins located at the restroom blocks and camper service areas. Garbage must be disposed of in closed bags following the instructions in the welcome sheet and local signage.
- 8) **Water fountains.** The water fountains in the camping area are for water extraction only. Dishes must be washed in the designated areas in the restrooms. It is strictly forbidden to dispose of any liquids that could harm the drainage system, such as cooking oils or solid materials.
- 9) **Quiet Hours.** FROM 2:00 PM TO 4:00 PM AND FROM 11:00 PM TO 8:00 AM, QUIET HOURS ARE ENFORCED (during high season, quiet hours may start at 11:30 PM). Moderation of noise is expected throughout the day. The use of devices that produce sound (smartphones, TVs, stereos, musical instruments, etc.) is allowed only at low volumes.
- 10) **Entertainment areas.** ¹The use of facilities, including the swimming pool and playground, is at your own risk. Parents are required to accompany their children when using these facilities.
²The use of the various fields (volleyball, bocce, and soccer) is strictly for the intended activity, and playing outside of these fields is prohibited.
³Animals are not allowed within the swimming pool area.
- 11) **Attention and Care.** Guests must take care of their personal belongings. The management is not responsible for theft or damage (including package delivered by courier), unless the items have been entrusted to the management and a receipt has been issued, which must be presented, along with an ID, when collecting the items. Money may also be deposited at the management office and can be withdrawn when necessary by presenting the original receipt.
- 12) **Pets.** Owners of dogs, cats, etc. are allowed only if they provide waste bags for cleaning up after their pets and keep them always on a leash. They are also responsible for any damage caused to people or property. They must ensure their pets do not disturb other guests who may not like animals. Dogs of any size are not allowed in the camping area from 12/07/2025 at 23/08/2025, and are never allowed inside the mobile homes.
- 13) **Air Conditioners.** Noisy air conditioners installed on campers or caravans that disturb neighbors are prohibited. They must remain switched off from 9:00 PM to 8:00 AM (from June 1 to September 15, from 11:00 PM to 8:00 AM). During other times, they may only be used if necessary, with the guests present in the pitch.
- 14) **Day Visitors.** ¹A day visitor must leave their ID at the reception and wait for the registered guest to arrive before accessing the campsite. They may use all facilities except the swimming pool.
²They may stay for free until 10:00 PM. By that time, they must collect their ID and leave. Any overnight stay must be communicated to the reception in advance.
³ Guests will be held responsible for any inappropriate behavior by their day visitors. Anyone who does not strictly adhere to these rules will be denied access.

ACCESS TO THE CAMPSITE IMPLIES ACCEPTANCE AND FULL COMPLIANCE WITH THESE RULES. FAILURE TO COMPLY WITH THESE RULES OR ANY BEHAVIOR DETRIMENTAL TO THE HARMONY AND SPIRIT OF THE GUESTS WILL, AT THE DISCRETION OF THE MANAGEMENT, RESULT IN EXPULSION FROM THE CAMPSITE.

“Cancellation 3 days”

The customer can cancel for free up to 11:59 PM of the fourth day before the start of the stay.

From 12:00 AM on the third day, the deposit is non-refundable.

“Cancellation 5 days”

The customer can cancel for free up to 11:59 PM of the sixth day before the start of the stay.

From 12:00 AM on the fifth day, the deposit is non-refundable.

“Cancellation 7 days”

The customer can cancel for free up to 11:59 PM of the eighth day before the start of the stay.

From 12:00 AM on the seventh day, the deposit is non-refundable.

“Cancellations and subsequent changes or no-shows”

Penalty: 30% of the total booking amount.
